NOTES FROM THE DIRECTOR

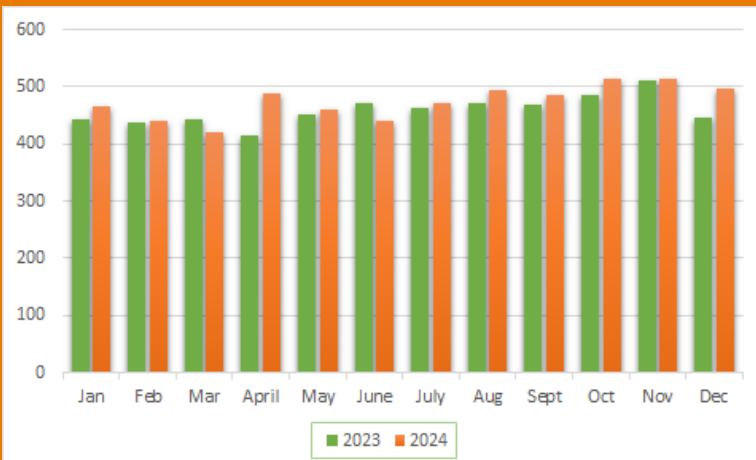
2024 has been another year of increases! Total people served increased by 7.2% over 2023. Seniors, children, and disabled people served increased by 3.2% over 2023. Financial Assistance increased 7.8% over last year. People assisted continued to increase monthly. This provides an insight into how tough a year 2024 was for everyone.

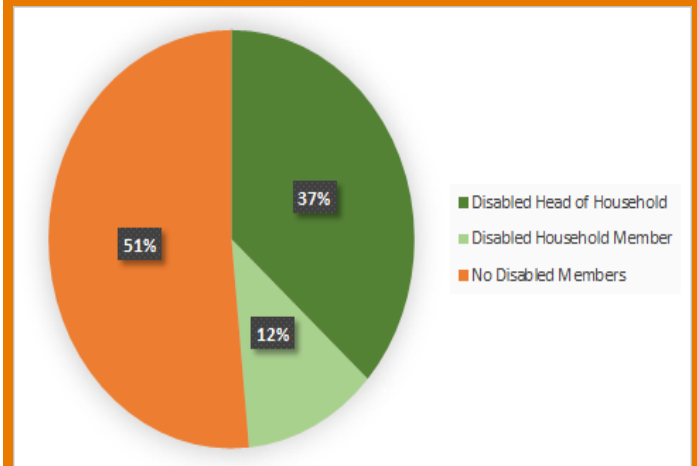
Number of Households Served Monthly

If you know of someone who may qualify for this, encourage them to apply!

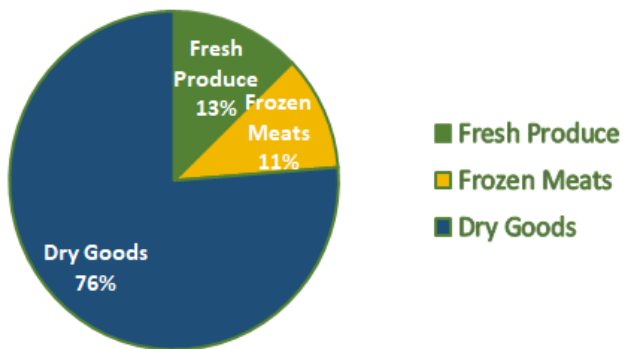
VITA Tax Program Volunteer Income Tax Assistance

In 2024, the LCGS tax office completed 379 tax returns for tax year 2023.

Assuming average tax return prep / fees of \$250, this program saved these taxpayers \$94,750 in fees.

An additional 12 prior year returns were completed for an additional \$3,000 in savings.

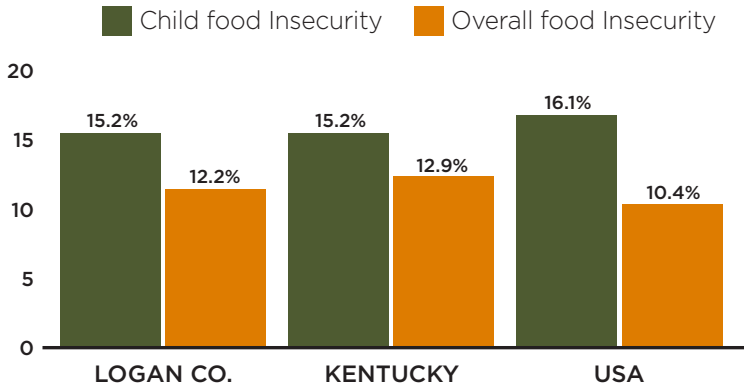
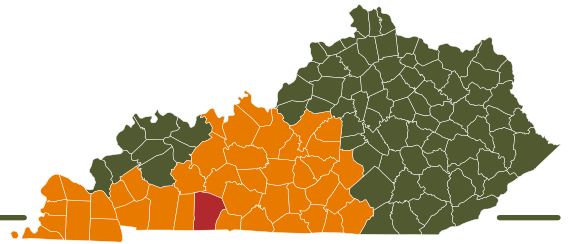
Types of Food Distributed

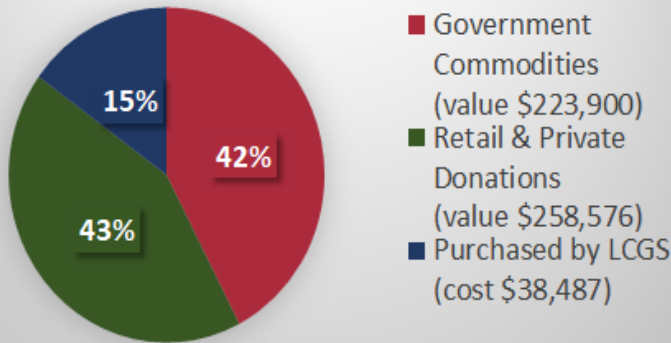

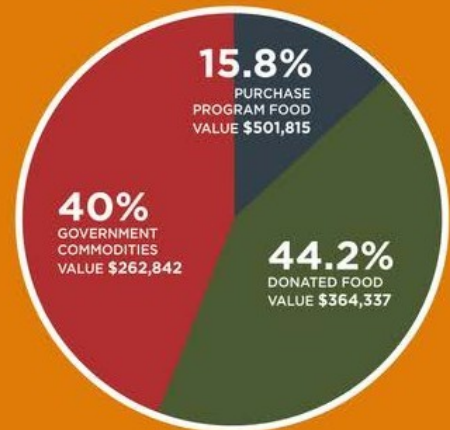
